

# A survey of smooth transition time series models

## Abstract:

This talk reviews the development of smooth transition threshold type models in time series analysis. In contrast to the jump transition threshold models, they are more amenable to large sample statistical analysis. Such models have been found useful in the modeling of volatility in financial time series. Recent developments using a Bayesian approach will also be reviewed.
